

## WHAT IS ITSME?

ITSME is a trusted app that allows you to securely manage your online identity. It simplifies your digital interactions by providing a single, secure way to log in to various services, create accounts, confirm transactions, and sign documents – all from your smartphone. Thanks to this you will be able to share data, confirm or digitally sign with:

- government and semi-government services;
- almost all Belgian banks;
- most insurances;
- Most health services and institutions;
- telecommunications providers;
- notaries, lawyers and accountants;
- financial services;

## HOW DOES ITSME WORK?

ITSME works by using your smartphone as a secure hub for your digital identity. Once you download the ITSME app and set it up with your personal code, you can use it to authenticate yourself without needing to remember multiple usernames and passwords. This method, known as multi-factor authentication (MFA), ensures that only you have access to your information. Each time you use ITSME, you'll confirm your actions with your personal code, ensuring your data remains private and secure.

You use ITSME in the same way everytime: you initiate an action like a login at a company, you receive a notification in your app and you confirm it through your personal code. This action is the same with every partner. To make it even easier you can enable your fingerprint or FaceID; remember that for electronic signatures you will have to put your secret code.





## ACTIVATION PROCEDURE

### HOW CAN YOU USE ITSME?

The main step is to activate the service. If you want to activate this service, you have two options: via bank or via eID.

#### With your bank card



The supported banks are the following: Belfius, BNP Paribas, KBC, CBC, ING, Fintro and Hello Bank. To activate ITSME via bank you will need your smartphone, your bank card reader, your credit card and its pin.



These are the steps to create your account:


3. Then click your bank on the list of supported banks, you will need to log in through your bank app.





5. You will receive a text message with a verification code; enter your 5-digit verification code in the app.





6. Choose your personal code and confirm again.




7. Congratulations! Your digital identity is now activated.


## With your eID



You will need your smartphone, your PC, an eID card reader, your eID card and its pin.

These are the steps to create your account:


1. First let's start by downloading the ISME app via Play store or Apple Store.





2. Surf this [link](#) via computer. Enter your phone number and e-mail address. Make sure to select the correct country code from the dropdown menu.




3. Then, connect your eID card reader to the computer and insert your eID card. Read and sign your ITSME contract by entering the eID PIN code.





4. You will receive your identification token, open the ITSME app on your smartphone, enter your phone number. Enter the identification token you received earlier.




5. You will receive a verification code via sms. Enter the 5 digits into the app.





6. Choose your ITSME code and confirm it.



7. Congratulations! Now your digital identity is activated.





## POSSIBLE ISSUES



### **Error connecting: How to resolve this issue?**

You may receive this error message when trying to connect to a government website from a mobile web browser or when attempting to log in to a government application.

Ensure your mobile browser is set as your default browser (avoid Samsung Internet) and that you are not using private mode. This will help you avoid this error message.

*TIP: If you access the partner page of the itsme application, you won't encounter this issue!*





## How can you block your ITSME account?

Have you clicked on a suspicious link or noticed suspicious activity? Do you want to block your account? You can block your account on the itsme website: <https://my.itsme-id.com/account/block>

- Provide your phone number and your first name(s). Note: Your first name(s) must be spelled exactly as on your identity card.
- Confirm that you want to block your itsme<sup>®</sup> account.
- Your account will be securely blocked (confirmation via SMS).

You can then reactivate your account using your eID or bank card.





## How can you change your phone number?

If your account is active, you can change your phone number in your itsme application.

Here's how:

- Open your itsme application and go to the menu (top right or left, depending on your device).
- Navigate to "my details" and update your phone number.
- Follow the steps and confirm.

Is your account not active? In that case, you can reactivate it with your new number [on this page](#). You'll need a PC with a card reader.

## Forgot your ITSME code?

If you've forgotten your itsme code, you need to block and reactivate your itsme account. Alternatively, delete your itsme app, reinstall it from the Apple App Store or Google Play Store, and reactivate your account.

Navigate to 'Security and Privacy' in the app menu, then 'Delete itsme'.






Confirm that you want to delete your account and authenticate with your itsme code, fingerprint, or facial recognition.

## How do you reactivate ITSME?

If you want to reuse ITSME later, you'll need to create a new account. Close and restart the app, then follow the steps to reactivate your account.

*Note: Always remember your original login credentials for our partner sites to avoid losing access.*

iPhone users (from iOS 16) can add a widget to their lock screen for easy and quick access to the itsme application.

How to do it? Here's a step-by-step guide:

- Long-press the lock screen until the
- Customize button appears, then tap Customize.
- Select Lock Screen.
- Press Add Widgets. (under the clock)



- Tap or drag the widgets you want to add to the lock screen.
- When finished, tap the close button, then tap Done.
- If there's not enough space for a new widget, you can press the remove button to delete a widget and make room for the one you want to add.

## Received an unintended action?

If you receive an itsme action that you didn't request yourself, always refuse the action. Do not validate anything without verifying first. If this happens more than once, immediately block your itsme account and contact our support service.


## How do you add other people to my ITSME?

Your itsme account is personal and consists of an identity document, phone number, and application. It's not possible to add other people to your account. If someone else wants to use itsme, they can download the itsme app themselves from the Apple App Store or Google Play Store and create an account.





## ICONS IN THE ITSME APPLICATION



### What do they mean?

Icons in the itsme application serve as an additional security measure. By selecting the same icon as shown on the website, you secure the connection between your browser and your itsme application.

### What do they mean?

During identification, login, or confirmation with itsme. Icons appear randomly or when you use a browser for the first time.

With each signature using itsme. By selecting the correct icon in the application, you validate the document to be signed. You'll be prompted for this step each time you sign.

If you see an incorrect sequence of icons or an incorrect orange icon in your application, reject the action and restart the process.
